Site Directions: From I-24, take exit 66, Sam Ridley Parkway, east 2.8 miles and merge onto US-41/US-70S towards Smyrna/LaVergne and travel north on "US-41N/US-70N/Murfreesboro Rd/Lowry St" (the road has a lot of names and numbers). Travel 1.3 miles to a light at Fergus Rd. and make a right onto Fergus Rd. Travel 0.8 miles and turn right on Jones Mill Rd.

Travel past the main entrance to the WMA for a total of 1.8 miles from Fergus Rd to the entrance to the Field Trial Area (there are signs). Make a left onto Old Jones Mill Rd and enter the WMA.
